



# Coronavirus & Subsequent Emergency Response Fund

To respond to the urgent needs and ever-changing guidance around caring for the Estes Valley community during the pandemic, EPHF's Board of Directors established the Coronavirus & Subsequent Emergency Response Fund in March of 2020. This fund has been the focus of fundraising for all of 2020.

With support from generous individuals, business donors, and foundations, EPHF has fully funded retrofitting 7 patient rooms to negative pressure rooms. These rooms enable Estes Park Health Staff to treat patients with COVID-19 in Estes Park rather than sending them to the Valley. To prevent the spread of COVID-19, the Foundation also funded the purchase of additional Personal Protective Equipment (PPE). In July, the Foundation paid for a COVID-19 direct RT-PCR testing machine. This machine is recommended by the CDC for its accurate test results and can run 8 tests at a time with results in 80 minutes. As soon as the machine was calibrated in September, staff at Estes Park Health started running tests around the clock. After the wildfire evacuation in October, the machine quickly became overwhelmed, which means results were taking longer.

Valley. The already maxed-out testing machine at Estes Park Health was backlogged further, so patients waited longer for results.

With COVID-19 positive cases surging in November, the Foundation approved funding for an additional COVID-19 direct RT-PCR testing machine to keep up with demand. In addition to supporting testing and treatment for all residents of the Estes Valley, the Foundation underwrites the costs of COVID-19 testing for the uninsured, both documented and undocumented.

"Availability of tests in conjunction with fast test results is a powerful tool in stopping the spread of COVID-19 in the Estes Valley," Mullin said. "The Board of the Estes Park Health Foundation stepped up to provide for this immediate need."

The next step in this campaign is to cover costs for storage, vaccine administration, and PPE/consumable supplies for vaccines given to the uninsured, both documented and undocumented. If you'd like to donate, visit **GivetoEPH.org/COVID19**.

"Quick results ensure that those who are negative can continue on with their everyday lives, while those that are positive can isolate and start care right away," said Kevin Mullin, EPHF's Executive Director.

In addition to the higher demand for testing after the wildfire evacuation, weather constraints forced the outdoor testing sites at Timberline and Salud of Estes Park to close in October, leaving Estes Park Health as the only option for COVID-19 testing in the Estes


"A lot of the flora and fauna are similar as well as the effects of the altitude and



# Samantha Cora Joins Estes Park Health Foundation



# **COVID-19 Vaccines at EPH**

EPH has been requesting substantial quantities of vaccine each week since they became available; we are at the discretion of the State of Colorado as to how many doses we are allotted. We are asking for many more doses than Colorado has yet provided. Colorado makes the allotments based on size and geographic coverage of the requesting entity. We want to get everyone vaccinated who wants to get vaccinated and will continue to work unceasingly with the state



and county to ramp up volumes until we get you covered. If you are able to get the vaccine elsewhere in the meantime, we encourage it, and of course we remind you that the need for masking and social distancing will remain in place for many months.

# \*NEW\* Estes Park Health Department Wish List

Estes Park Health Department Directors request over \$3 million in capital funds every year, including equipment upgrades needed to continue their work at Estes Park Health. EPH has an annual capital budget of around \$1.3 million, so less than half of those requests are funded. Due to COVID-19, capital expenditures are on hold for 2021, except for emergencies. #### **Estes Park Health EMS**

EPH EMS is in need of King Vision Videoscopy replacements. These are utilized for video intubation, which improves successful intubation of critical patients on the first attempt. Our current supply is getting aged and we have replaced one already this year. Additionally, we need 1 to replace a failed device in one of our ambulances.

Cost per Unit: \$1,400 — Quantity Needed: 3



#### **Estes Park Health Laboratory**

The EPH Laboratory needs a new refrigerator to relieve the overloaded ones in the lab. Many patients are ill and new tests are being developed daily. More testing is being done in the lab, which means more space is required. With a new refrigerator, we can run more tests, reduce shipping and handling fees, and house reagents when new tests are moved in-house. Additionally, the current refrigerators are always full so we have no back-up space if one goes down.
