On behalf of the Estes Park Health Foundation Board of Directors, I would like to thank everyone who made 2020 a successful year. Despite COVID-19, wildfire evacuations of our town and hospital, and the turbulent political climate, we moved forward. I am in awe of your generosity, compassion, and ability to continue to make a difference to the residents of the Estes Valley and beyond.

When COVID-19 reared its ugly head, the Foundation responded by creating an Emergency Response Fund with the goal of raising \$150,000. Phase I included the purchase of PPE (Personal Protective Equipment) and the retrofitting of 7 patient rooms with negative pressure. As part of Phase II, EPHF supported the purchase of COVID-19 testing

equipment and testing access for the underserved. In Phase III, we provided additional testing equipment, access to testing, and helped underwrite community vaccinations. Executive Director Mullin had this to say, "To every donor and volunteer involved in this effort, Estes Park Health Foundation and I offer you our sincere thanks. Through your generosity we raised more than \$300,000."

It is my pleasure to present this annual report. As you will see, the Foundation continues to gain experience and efficiency, while maintaining their commitment to excellence. The success of the Foundation comes from all of you. The success also comes from the amazing efforts of Peggy Savelsberg, and now Theresa Brynard, Kaci Yoh, and Kevin Mullin. It has been a pleasure working with our team this past year. # **CORONAVIRUS & SUBSEQUENT EMERGENCY RESPONSE FUND**

To respond to the urgent needs and ever-changing guidance around caring for the Estes Valley community during the pandemic, EPHF's Board of Directors established the Coronavirus & Subsequent Emergency Response Fund in March of 2020. This fund has been the focus of fundraising for all of 2020.

With support from generous individuals, business donors, and foundations, EPHF has fully funded the creation of 7 negative pressure rooms at Estes Park Health so staff can treat residents with COVID-19 right here in Estes Park rather than sending them to the Valley. The Foundation also funded the purchase of additional Personal Protective Equipment (PPE) to prevent the spread of COVID-19 to patients and staff. In July, the Foundation paid for a COVID-19 direct RT-PCR testing machine. This machine is recommended

by the CDC for its accurate results and can run 8 tests at a time with results in 80 minutes. As soon as the machine was calibrated in September, staff at Estes Park Health started running tests around the clock, and, after the wildfire evacuation in November, the machine quickly became overwhelmed, which meant results were taking longer.

In addition to the higher demand for testing after the wildfire evacuation, weather constraints forced the outdoor testing sites at Timberline and Salud of Estes Park to close in October, leaving Estes Park Health as the only option for COVID-19 testing in the Estes Valley. The already maxed-out testing machine at Estes Park Health was backlogged further, so patients waited longer for results. With COVID-19 positive cases surging in November, the Foundation approved funding for an additional COVID-19 direct RT-PCR testing machine to keep up with demand. In addition to supporting testing and treatment for all residents of the Estes Valley, the Foundation has been underwriting the cost of COVID-19 testing for the uninsured, both documented and undocumented.

In late 2020, EPHF began the next step in this campaign, which is to assist with costs for vaccine administration by EPH staff including labor, storage, transportation, and PPE/consumable supplies.

#### 2020 was a year like no other.




